I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of this rental agreement and participating in snowshoeing activities against the Wheaton Park District, including its officials, agents, volunteers and employees. Furthermore, in consideration of the rental of snowshoe equipment, I agree to reimburse the Park District for any damage or loss of the equipment, normal wear being excepted.
